## ORDINANCE NO. 27

AN ORDINANCE AMENDING ORDINANCE NO. 13, SERIES OF 1965, ENTITLED, "AN ORDINANCE REQUIRING CLEARANCE AND PERMIT FROM THE CITY MAYOR FOR HIRING SECURITY GUARDS, SPECIAL POLICEMEN OR WATCHMEN OF ESTABLISHMENTS DOING BUSINESS IN ORMOC CITY AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF"

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

Provisions of Ordinance No. 13, series of 1965, entitled "An Ordinance Requiring Clearance and Permit From the City Mayor for Hiring Security Guards, Special Policemen or Watchmen of Establishments Doing Business in Ormoc City and Providing Penalties for Violations Thereof," are hereby amended to read as follows:

SECTION 1. Any partnership, firm, corporation or entity and the like doing business in Ormoc City and desiring to hire security guards, special policemen or watchmentfor their business establishments shall secure the necessary clearance and permit from the City Mayor.

By the term "clearance" is meant certification to show that the person or the applicant for the position of security guard, special policeman or watchman is of good moral character and without any criminal record.

SECTION 2. Permit fee. - There shall be paid to the City Treasurer an annual permit fee of Ten Pesos (1910) by any person desiring to be employed as security guard, special policeman or watchman in any establishment doing business in Ormoc City. For purposes of this Ordinance, all existing security guards, special policemen or watchmen within the territorial limits of Ormoc City shall be considered as new unless they have previously secured permits from the City Mayor or are members of duly licensed security agencies in Ormoc City.

SECTION 3. Time and manner of payment and penalty for delinquency. - The permit fee herein prescribed shall be payable without penalty with-In twenty (20) days from the start of every calendar year: PROVIDED, HOW-EVER, That upon approval of this Ordinance the taxpayer shall be given sixty (60) days within which to pay the annual permit fee due this year. Failure to pay within the prescribed periods shall render the taxpayer subject to a surcharge of twenty-five percentum (25%) for the first offense and fifty-percentum (50%) for subsequent failures to pay within the prescribed time.



SECTION 4. It shall be unlawful for any partnershipk firm, corporation or entity and the like to employ any security guard, special policeman or watchman other than members of any duly licensed security agency in Ormoc City.

SECTION 5. No partnership, firm, corporation or entity and the like shall employ any security guard, special policeman or watchman unless the provisions of the preceding four (4) sections shall have been fully comlied with.

SECTION 6. Penalty for violation. - Any violation of the provisions of this Ordinance shall be punishable by a fine of not less than One Hundred Pesos (P100) but not exceeding Five Hundred Pesos (P500) and an imprisonment of not less than thirty (30) days but not exceeding sixty (60) days. If the violation is committed by a partnership, firm or corporation, the managing partner, manager, managing director or person charged with the management shall be held criminally liable or responsible therefor: PROVIDED, HOWEVER, That anybody accepting a position of security guard, special policeman or watchman in any establishment subject to this Ordinance shall be, likewise, rendered subject to the penalties prescribed herein.

SECTION 7. Repeal. - Any existing ordinance or parts of ordinances inconsistent with the provisions of this Ordinances are hereby repealed or modified accordingly.

SECTION 8. Effectivity. - This Ordinance shall take effect immediately upon its approval.
