ORDINANCE NO. 28

AN ORDINANCE REVERTING THE SUM OF FIVE THOUSAND PESOS FROM SALARY SAVINGS IN THE CITY INTERMEDIATE SCHOOL FUND. 1964-1965 ORMOC CITY BUDGET, FOR ELECTRIC CURRENT CONSUMPTION OF DONATED MERCURY VAPOR BULBS

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of Five Thousand Pesos (\$5,000) or so much thereof is hereby reverted from out of the salary savings in the City Intermediate School Fund, 1964-1965 Ormoc City Budget, to be made available for appropriation for payment of electric current consumption of Mercury Vapor Bulbs donated by civic-spirited citizens of OrmocCCity;
