## ORDINANCE NO. 29

AN ORDINANCE REVERTING THE SUM OF SIX THOUSAND FIVE HUNDRED PESOS (\$6,500) FROM SALARY SAVINGS IN THE CITY INTER-MEDIATE SCHOOL FUND, 1964-1965 ORMOC CITY BUDGET, FOR THE INSTALLATION OF NINE (9) MERCURY LAMP POSTS AND ACCESSORIES AT THE ORMOC PIER

BEI IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 189, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of Six Thousand Five Hundred Pesos (\$6,500) or so much thereof is hereby reverted from out of the salary savings in the City Intermediate School Fund, 1964-1965 Ormoc City Budget, to be made available for appropriation for the installation of nine (9) mercury lamp posts and their accessories per estimate submitted by the City Engineer for the Ormoc City pier.

SECTION 2. This Ordinance shall take effect immediately upon approval.
