RESOLUTION NO. 64

"WHEREAS, Mrs. Francisca Palacio, widow of the late Ireneo Palacio, Barrio Captain of Milagro, this City, has appealed to this august Body in her letter dated March 15, 1965, for burial expenses and other remuneration of her husband who died in line of duty in a fatal accident on July 2, 1964, invoking in that connection upon the provisions of Section 699 of the Revised Administrative Code, as amended by Republic Act 1232, considering that her late husband derived no death benefits from the insurance company because the policy was still in the name of the former barrio captain, Lamberto Katangkatang, and that her husband was not even receiving compensations as such barrio captain of Milagro;

"WHEREAS, this august Body believes that the claim of Mrs. Palacio is justifiable taking into account her reasons stated above;

"NOW, THEREFORE, the Board, on motion of Floor Leader Tugonon, seconded by the Presiding Officer, Councilors Kierulf, Abas, and Besabella;

"RESOLVED, to adopt:

ORDINANCE NO. 30

AN ORDINANCE REVERTING THE SUM OF ONE THOUSAND PESOS (P1,000) FROM SALARY SAVINGS, CITY INTERMEDIATE SCHOOL FUND, 1964-1965 ORMOC CITY BUDGET, FOR BURIAL EXPENSES AND OTHER REMUNERATION ACCRUING TO THE LATE BARRIO CAPTAIN IRENEO PALACIO WHO DIED IN LINE OF DUTY ON JULY 2, 1964

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, pursuant to the provisions of Republic Act 179, as amended, That:

SECTION 1. The sum of One Thousand Pesos (P1,000) or so much thereof is hereby reverted from out of salary savings in the City Intermediate School Fund, 1964-1965 Ormoc City Budget, to be made available for appropriation for burial expenses and other remuneration accruing to the late Barrio Captain Ireneo Palacio of Milagro, Ormoc City, pursuant to Section 699 of the Revised Administrative Code as amended by Republic Act 1232.

SECTION 2. This Ordinance shall take effect immediately upon approval.
