## ORDINANCE NO. 32

AN ORDINANCE CONDONING THE PENAL PROVISION OF ORDINANCE NO. 7, SERIES OF 1964, AS AMENDED, ENTITIED "AN ORDINANCE IMPOSING A STORAGE TAX OF \$2.50 FOR EVERY TON OF HEMP, MAGUEY, AND THE LIKE AND PO.15 FOR EVERY SACK OF COPRA AND THE LIKE, SOLD, STORED, PURCHASED, KEPT OR SHIPPED IN ORMOC CITY"

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The penal provision for delinquency in Ordinance No. 7, series of (1964) as amended, entitled, "An Ordinance Imposing a Storage Tax of ₱2.50 for every Ton of Hemp, Maguey, and the like, and ₱0.15 for every Sack of Copra and the like, Sold, Stored, Purchased, Kept or Shipped in Ormoc City," more particularly the imposition of surcharges for failures to pay on time, is hereby condoned for one (1) year only effective as of the effecitivity of said Ordinance No. 7, series of 1964, PROVIDED: That this condonation shall apply only to taxpayers who are willing to pay the regular payment of taxes and PROVIDED, FURTHER, That this Ordinance shall not apply to taxpayers who have already paid said taxes to the City Treasurer.

SECTION 2. This Ordinance shall take effect as of the effectivity of Ordinance No. 7, series of 1964.
