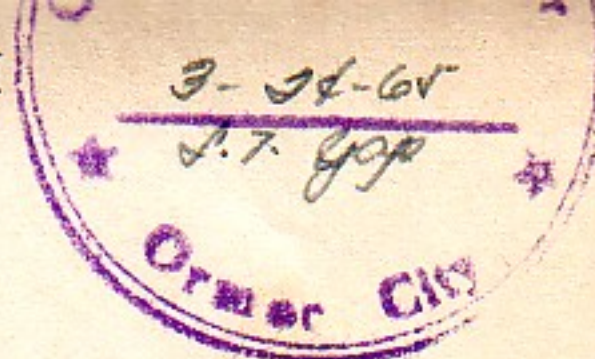


EXCERPT FROM THE MINUTES OF THE REGULAR SESSION OF THE FIFTH

"RESOLVED, to adopt:

ORDINANCE NO. 32

AN ORDINANCE REVERTING THE SUM OF ₱138.63 FROM ITEM NO. 38, (C-15) POLICE DEPARTMENT, PAGE 10, 1964-1965 ORMOC CITY BUDGET, FOR SALARY DIFFERENCE OF POLICE INSPECTOR THIRD CLASS RESTITUTO MARIVELES

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of One Hundred Thirty-Eight Pesos and Sixty-Three Centavos (₱138.63) or so much thereof is hereby reverted from out of Item No. 38, (C-15) POLICE DEPARTMENT, page 10, 1964-1965 Ormoc City Budget, to be made available for appropriation to pay the salary difference accruing to Police Inspector Third Class Restituto Mariveles, Ormoc City Police Department, for the period from February 12 to June 30, 1964, inclusive, or at the rate of Thirty Pesos (₱30.00) per month.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
