ORDINANCE NO. 33

AN ORDINANCE REVERTING THE SUM OF ONE THOUSAND THREE HUNDRED PESOS (₱1,300) FROM SALARY SAVINGS IN THE CITY INTERMEDIATE SCHOOL FUND, 1964-1965 ORMOC CITY BUDGET, FOR BARRIO AID TO MANLILINAO AND FOR OTHER PURPOSES

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of One Thousand Three Hundred Pesos (\$1,300) or so much thereof is hereby reverted from out of salary savings in the City Intermediate School Fund, 1964-1965, Ormoc City Budget, to be made available for appropriation as barrio aid and city counterpart for the purchase of eighty (80) pieces of pipes, 1" x 20', for the completion of the PACD waterworks project in Barrio Manlilinac.
