RESOLUTION NO. 93

"The Board, on motion of Councilor Besabella, seconded by the Presiding Officer, the Floor Leader and Councilor Abas;

"RESOLVED, to adopt:

ORDINANCE NO. 34

AN ORDINANCE REVERTING THE SUM OF SEVEN HUNDRED PESOS (P700) FROM SALARY SAVINGS IN THE INTERMEDIATE SCHOOL FUND, 1964-1965 ORMOC CITY BUDGET, AS BARRIO AID TO SAN JOSE FOR THE CONSTRUCTION OF A LOW-COST BUILDING (MODEL HOUSE) WITHIN THE PREMISES OF THE SAN JOSE COMMUNITY SCHOOL

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. As requested by the Barrio Council of San Jose, Ormoc City, in its Resolution No. 27 dated January 2, 1965, and as approved by the Board, the sum of Seven Hundred Pesos (P700) or so much thereof is hereby reverted from out of salary savings in the Intermediate School Fund, Ormoc City Budget of 1964-1965, to be made available for appropriation as barrio and school aid to San Jose for the completion of the low-cost building (model house) within the premises of San Jose Community School, Ormoc City.

SECTION 2. This Ordinance shall take effect immediately upon its approval.

ENACTED, March 17, 1965.

"RESOLVED, FINALLY, to furnish a copy of this resolution-ordinance each to the Barrio Council of San Jose, the City Treasurer and the City Auditor, all of Ormoc City;
