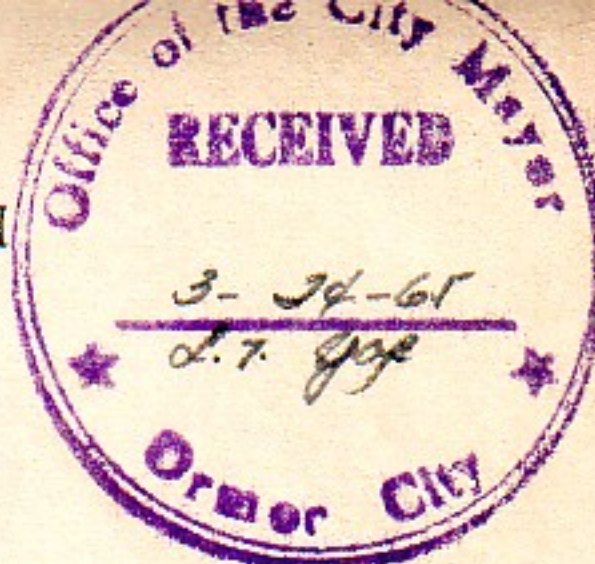


EXCERPT FROM THE MINUTES OF THE REGULAR SESSION OF THE FIFTH

"The Board, on motion of Floor Leader Tugonon, seconded by the Presiding Officer and Councilor Abas;

"RESOLVED, to adopt:

ORDINANCE NO. 35

AN ORDINANCE REVERTING THE SUM OF TWO HUNDRED FIFTY PESOS (P250) FROM SALARY SAVINGS, INTERMEDIATE SCHOOL FUND, 1964-1965 ORMOC CITY BUDGET, FOR BARRIO AND SCHOOL AID TO SABANG BAO FOR THE REPAIR OF ROOFING OF THE SABANG BAO COMMUNITY SCHOOL BUILDING

BE IT ORDAINED, by authority of the Municipal Board, of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. As requested by the Barrio Council of Sabang Bao, Ormoc City, in its Resolution No. 84 dated January 30, 1965, and duly approved by the Board, the sum of Two Hundred Fifty Pesos (P250) or so much thereof is hereby reverted from out of salary savings in the Intermediate School Fund, 1964-1965 Ormoc City Budget, to be made available for appropriation as barrio and school aid to Sabang Bao for the repair of the roofing of the three-room temporary school building therein.

SECTION 2. This Ordinance shall take effect immediately upon its approval.

ENACTED, March 17, 1965.
