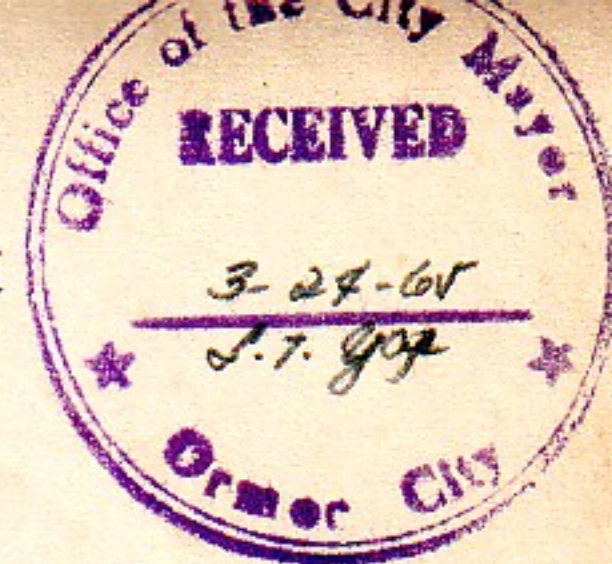

"The Board, on motion of CFloor Leader Tugonon, seconded by the Pre-
siding Officer and Councilors Alfaro and Besabella;

"RESOLVED, to adopt:

ORDINANCE NO. 37

AN ORDINANCE REVERTING THE SUM OF FIVE HUNDRED PESOS (P500)
FROM SALARY SAVINGS IN THE INTERMEDIATE SCHOOL FUND, 1964-
1965 ORMOC CITY BUDGET, FOR BARRIO AND SCHOOL AID TO MAS-
IN FOR THE REPAIR OF THE MAS-IN COMMUNITY SCHOOL BUILDING

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City,
Philippines, pursuant to the provisions of Republic Act 179, as amended
by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of Five Hundred Pesos (P500) or so much thereof
is hereby reverted from out of salary savings in the Intermediate School
Fund, 1964-1965 Ormoc City Budget, to be made available for appropriation
as barrio and school aid to Mas-in for the repair of the Mas-in Community
School building.

SECTION 2. This Ordinance shall take effect immediately upon its
approval.

ENACTED, March 17, 1965.
