"RESOLVED, to adopt:

ORDINANCE NO. 38

AN ORDINANCE REVERTING THE SUM OF ONE THOUSAND PESOS (\$1,000) FROM SALARY SAVINGS IN THE INTERMEDIATE SCHOOL FUND, 1964-1965 ORMOC CITY BUDGET, FOR BARRIO AND SCHOOL AID TO CAN-ADIENG FOR THE REPAIR OF THE COMMUNITY SCHOOL BUILDING

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of One Thousand Pesos (\$1,000) or so much thereof is hereby reverted from out of salary savings in the Intermediate School Fund, 1964-1965 Ormoc City Budget, to be made available for appropriation as barrio and school aid to Can-adieng for the repair of the Can-adieng Community School building.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
