ORDINANCE NO. 39

AN ORDINANCE REVERTING THE SUM OF ONE THOUSAND PESOS (1,000) FROM THE DISCRETIONARY FUND OF THE CITY MAYOR FOR REPRE-SENTATION EXPENSES IN CONNECTION WITH THE INAUGURATION OF THE PANALIAN BRIDGE ON MARCH 28, 1965

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of One Thousand Pesos (\$1,000) or so much thereof is hereby reverted from out of the Discretionary Fund of His Honor, the City Mayor, to be made available for appropriation as representation expenses of the City Government in connection with the inauguration of the Panalian Bridge, Ormoc City;
