RESOLUTION NO. 6

"WHEREAS, acting on our Resolution No. 294, series of 1964, Mr. Cornelio V. Crucillo, Director of Foreign Aid Coordination, National Economic Council, Manila, has in his communication dated October 28, 1964, informed that requests for excess U.S. property under their international development program must comply with four requirements specially in connection with our request for five jeeps for the use of various departments of the City Government;

"WHEREAS, this august Body will remember having appropriated for the estimated cost for transporation and repair only \$1,000 for each jeep (\$\mathbb{P}_5,000 for the five jeeps) so that said appropriation is short by \$\mathbb{P}_500 per jeep (\$\mathbb{P}_2,500) for the five jeeps);

"NOW, THEREFORE, the Board, on motion of Councilor Abas, seconded by the Presiding Officer, the Floor Leader and Councilors Alfaro, Du and Penges;

"RESOLVED, to comply with the requirements set by the National Economic Council on the five jeeps requested for the use of the City medifying in this connection our Resolution No. 294, series of 1964, and do, as this Body hereby does, adopt:

ORDINANCE NO. 4

AN ORDINANCE REVERTING THE SUM OF TWO THOUSAND FIVE HUNDRED PESOS (\$\frac{1}{2}\$,500) FROM OUT OF ITEM NO. 38, (C-15) POLICE DEPARTMENT, PAGE 10, 1964-1965 ORMOC CITY BUDGET, FOR ADDITIONAL COST OF TRANSPORTATION AND REPAIR OF FIVE JEEPS FROM THE NATIONAL ECONOMIC COUNCIL FOR USE OF THE CITY GOVERNMENT AND FOR OTHER PURPOSES

BE IT ORDAINED, by authority of the Municipal Beard of Ormoc City, Philippines, pubsuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of Two Thousand Five Hundred Peses (\$\frac{P}{2}\$,500) or so much thereof is hereby reverted from out of Item No. 38, (C-15) Police Department, page 10, 1964-1965 Ormoc City Budget, to be made available for additional cost of transportation and repair of five jeeps requested from the National Economic Council for use of the City of the following types and details regarding justification and intended utilization of each item, viz:

- a) Two (2) pelice jeeps for use of the members of the Ormoo City Pelice Department on patrol duty, for apprehending criminals in faraway barries comprising Ormoc City, and all other pelice activities in the enforcement of law and order;
- b) Two (2) service jeeps for use of members of the Municipal Beard in their frequent visits to their councilor districts to attend to their needs in line with the policy of the local administration in bringing



THE Government closer to the people; and

() One (1) service jeep for use of the City Finance Department in the intensification of tax collections not only within the city proper but also in the barrios,

without which jeeps the City cannot cope much with the implementation of the socio-economic development program of the Republic of the Philippines as enunciated by no other than His Excellency, President Diosdado Macapagal. It is understood in this connection that there are facilities and personnel to properly utilize, maintain and operate these vehicles once acquired from the National Economic Council considering that Ormoc City has its own motor pool under the direct control and supervision of the City Engineer and that there are personnel who could shoulder respensibilities in the proper utilization, maintenance and operation of these vehicles.

SECTION 2. The City Treasurer is hereby directed to issue a certificate of the availability of \$5,000 in accordance with our Resolution No. 294, series of 1964, and P2,500 in accordance with this resolutionordinance (or a total of \$7,500) to the National Economic Council for the transportation and repair of the five jeeps above requested.

SECTION 3. This Ordinance shall take effect immediately upon its approval.
