RESOLUTION NO. 99

"The Board, on motion of Councilor Abas, seconded by the Presiding Officer, the Floor Leader and Councilor Du;

"RESOLVED, to adopt:

ORDINANCE NO. 40

AN ORDINANCE REVERTING THE SUM OF ONE THOUSAND THREE HUNDRED FIFTY-FIVE PESOS (P1,355) FROM THE DISCRETIONARY FUND OF OF THE CITY MAYOR FOR PAYMENT OF CLAIMS FOR SALARY OF HIS TECHNICAL ASSISTANT FROM AUGUST, 1963, TO JULY 15, 1964.

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of One Thousand Three Hundred Fifty-Five Pesos (P1,355) or so much thereof is hereby reverted from out of the Discretionary Fund of His Honor, the City Mayor, to be made available for appropriation as payment for the claims for salary of Atty. Federico P. Pasana, erstwhile Technical Assistant in the Office of the City Mayor, for the period from August, 1963, to July 15, 1964, at the rate of P120 per month.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
