RESOLUTION NO. 106

"The Board, on motion of Councilor Abas, seconded by the Presiding Officer, the Floor Leader, and Councilors Besabella and Du;

"RESOLVED, to adopt:

ORDINANCE NO. 42

AN ORDINANCE REVERTING THE SUM OF ₱25,000 FROM SALARY SAVINGS IN THE INTERMEDIATE SCHOOL FUND, 1964-1965 ORMOC CITY BUDGET, AND INCORPORATING THE SAME TO ITEM NO. 2, CEMENTING OF CITY STREETS UNDER CAPITAL OUTLAY, PAGE 14, SAME BUDGET, AND FOR OTHER PURPOSES.

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of ₱25,000 or so much thereof is hereby reverted from out of salary savings in the Intermediate School Fund, 1964-1965 Ormoc City Budget, to be incorporated to Item No. 2, Cementing of City Streets, under Capital Outlays, page 14 of the said budget.

SECTION 2. Consequent to this reversion, the amount of ₱7,710 is hereby appropriated from out of the appropriation for the cementing of city streets to be made available for payment of the road-right-of-way claims of Generosa Conui et al, in the manner hereunder provided, viz:

- a) on Lots Nos. 714 and 715 abutting Mabini,
Burgos and Aviles Streets ₱ 6,840.00
- b) on Lot No. 493 abutting Bonifacio Street ... 870.00

SECTION 3. This Ordinance shall take effect immediately upon its approval.
