ORDINANCE NO. 43

AN ORDINANCE REVERTING THE SUM OF ₱44 FROM SALARY SAVINGS IN THE INTERMEDIATE SCHOOL FUND, 1964-1965 ORMOC CITY BUDGET FOR THE REPAIR OF THE MABINI COMMUNITY SCHOOL BUILDING

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of ₱44 or so much thereof is hereby reverted from out of salary savings, in the Intermediate School Fund, 1964-1965 Ormoc City Budget, to be made available for appropriation as barrio aid to Mabini for the repair of the Mabini Community School building.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
