"RESOLVED, to adopt:

ORDINANCE NO. 44

AN ORDINANCE REVERTING THE SUM OF ₱220.50 FROM SALARY SAVINGS IN THE INTERMEDIATE SCHOOL FUND, 1964-1965 ORMOC CITY BUDGET, FOR PAYMENT OF MATERIALS IN THE PERGOLA AND FENCE CONSTRUCTION, SABANG BAO ELEMENTARY SCHOOL, ORMOC CITY

BE IT ORDAINED, by authority of the Municipal Board of, Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of ₱220.50 or so much thereof is hereby reverted from out of salary savings in the Intermediate School Fund, 1964-1965 Ormoc City Budget, to be made available for appropriation as barrio aid to Sabang Bao for the payment of materials used in the construction of the pergola and fence of the Sabang Bao Elementary School.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
