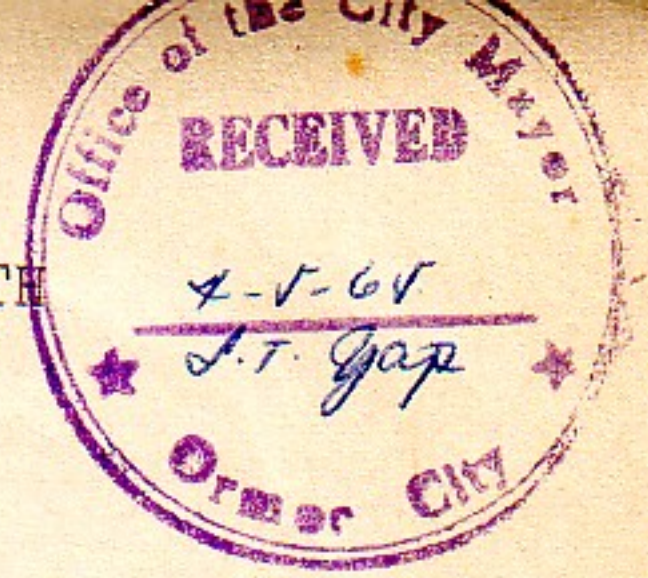

"RESOLVED, to adopt:

ORDINANCE NO. 45

AN ORDINANCE REVERTING P594 FROM SALARY SAVINGS ACCRUING TO
THE AUDITING DEPARTMENT, 1964-1965 ORMOC CITY BUDGET,
FOR SETTLEMENT OF LONG OUTSTANDING OBLIGATIONS IN THE
SAME DEPARTMENT

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City,
Philippines, pursuant to the provisions of Republic Act 179, as amended
by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of P594 or so much thereof is hereby reverted
from out of salary savings accruing to the Auditing Department, (C-3)
1964-1965 Ormoc City Budget, to be made available for appropriation to
settle just and long outstanding obligations of this City in the follow-
ing manner hereunder provided, to wit:

- a) Unpaid salary of Mr. Daciano Palami, former
Assistant City Auditor, Feb. 1-Mar. 31, 1956 P 400.00
- b) Traveling Expenses of Mr. Palami in Mar. 1956 194.00

SECTION 2. This Ordinance shall take effect immediately upon its
approval.
