ORDINANCE NO. 46

AN ORDINANCE REVERTING \$684.39 FROM SALARY SAVINGS IN THE INTERMEDIATE SCHOOL FUND, 1964-1965 ORMOC CITY BUDGET, FOR THE RECONSTRUCTION AND/OR IMPROVEMENT OF THE CITY STAGE
