ORDINANCE NO. 47

AN ORDINANCE REVERTING \$600 FROM SALARY SAVINGS IN THE INTER-MEDIATE SCHOOL FUND, 1964-1965 OFMOC CITY, BUDGET, FOR BARRIO AID TO RUFINA MEDALLE-TAN FOR THE COMMUNITY SCHOOL

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of \$\mathbb{P}600 or so much thereof is hereby reverted from salary savings in the Intermediate School Fund, 1964-1965 Ormoc City Budget, to be made available for appropriations for barrio aid to Rufina Medalle-Tan in the manner hereunder provided, to wit:

a) for the construction of one temporary school room ... \$ 250.00

b) for workshop and garden house 150.00 c) for clinic and office of the head teacher

100.00 d) for work men of these projects 100.00

SECTION 2. This Ordinance shall take effect immediately upon its approval.
