"RESOLVED, to adopt:

ORDINANCE NO. 48

AN ORDINANCE CREATING THE POSITION OF CLERK IN THE AUDITING DEPARTMENT WITH COMPENSATION AT THE RATE OF ₱1,680 PER ANNUM, PROVIDING FUNDS THEREFOR, AND FOR OTHER PURPOSES

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The position of one (1) clerk in the (C-3) Auditing Department, this City, is hereby created with compensation at the rate of ₱1,680 per annum, effective April 16, 1965.

SECTION 2. Subsequent to the creation of this position, the sum of ₱350 or so much thereof is hereby reverted from out of salary savings accruing to the Auditing Department which shall be made available for appropriation for the salary corresponding hereto up to the end of the current fiscal year; PROVIDED, HOWEVER, That subsequent appropriations be made in ensuing Ormoc City Budget.

SECTION 3. This Ordinance shall take effect as provided for in Section 1 hereof.

ENACTED, April 7, 1965.

"RESOLVED, FINALLY, to furnish a copy of this resolution each to the Honorable Auditor General and the Honorable Civil Service Commissioner, both of Manila, the City Auditor and the City Treasurer, both of Ormoc City, the latter for purposes of a supplemental budget;
