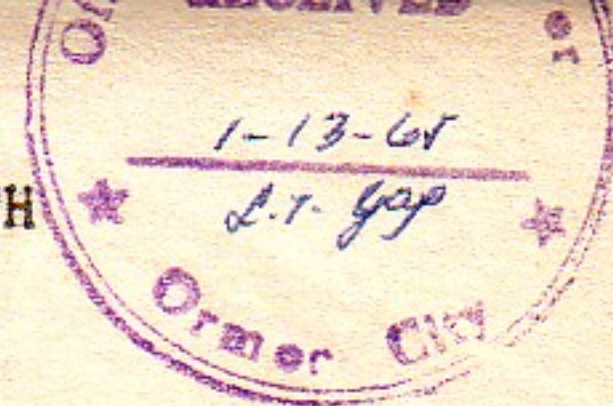

ORDINANCE NO. 5

AN ORDINANCE REVERTING THE SUM OF SEVEN HUNDRED PESOS (P700)
FROM OUT OF SAVINGS IN THE AUDITING DEPARTMENT TO THE
ITEM ON TRAVELING EXPENSES OF THE SAME DEPARTMENT

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of Seven Hundred Pesos (P700) or so much thereof is hereby reverted from out of savings in the Auditing Department to be made available for appropriation for traveling expenses in the said department in the manner hereunder provided as follows:
