RESOLUTION NO. 143

"WHEREAS, this august Body feels the urgency of sending a representative to the Bureau of Internal Revenue, Manila, considering that up to the present the allotments for Ormoc City from income tax and other sources have not yet been released by the National Government;

"WHEREAS, this Board firmly believes that our colleague, the Honorable Councilor Marciano S. Du, is among the best to represent us in the Bureau of Internal Revenue as well as other national offices in Manila in following up matters of great importance to the City of Ormoc;

"NOW, THEREFORE, the Board, on motion of Councilor Pongos, seconded by Councilor Abas;

"RESOLVED, to authorize the Honorable Councilor Marciano S. Du to represent this august Body to make representations with the Bureau of Internal Revenue in Manila for the early release of allotments accruing to Ormoc City and to follow up other matters of importance affecting our City;

"RESOLVED, FURTHER, in this connection, to adopt:

ORDINANCE NO. 52

AN ORDINANCE REVERTING THE SUM OF P500 FROM OUT OF SALARY SAVINGS ACCRUING TO THE POLICE DEPARTMENT FOR TRAVELING EXPENSES OF COUNCILOR MARCIANO S. DU TO MANILA AND FOR OTHER PURPOSES.

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of Five Hundred Pesos (P500.00) or so much thereof is hereby reverted from out of salary savings accruing to the Police Department which was appropriated for the maintenance and repair of the five (5) service jeeps requisitioned from the Agency for International Development, thru the National Economic Council, but which could not be available up to the present due to the loss of our papers in the offices above mentioned, per our Resolution No. 294, series of 1964, said sum to be made available for the traveling expenses of Councilor Marciano S. Du in going to Manila to make representations with the Bureau of Internal Revenue for the early release of allotments accruing to the City of Ormoc and to follow up all other matters in the national offices affecting the general benefit and welfare of this City.

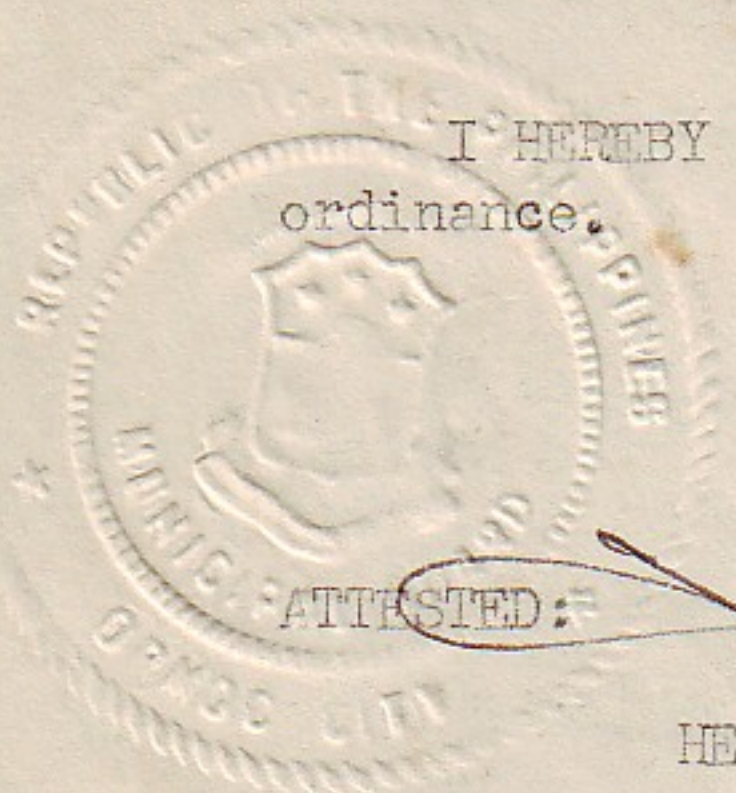
SECTION 2. This Ordinance shall take effect immediately upon its approval.
