RESOLUTION NO. 146

"WHEREAS, Mr. Asisclo S. Fiel, public school teacher, this City, has made representations with this august Body that he may collect the balance of his salary difference in the amount of ₱382.80 which he needs to finance his oral examination, paper and binding expenses, and other miscellaneous costs in connection with the finishing of his Master of Arts degree in Education course this summer;

"NOW, THEREFORE, the Board, on motion of Councilor Abas, seconded by Councilor Kierulf;

"RESOLVED, to adopt:

ORDINANCE NO. 55

AN ORDINANCE REVERTING THE SUM OF ₱382.80 FROM OUT OF SALARY SAVINGS IN THE INTERMEDIATE SCHOOL FUND, 1964-1965 ORMOC CITY BUDGET, FOR SALARY DIFFERENCE OF MR. ASISCLO S. FIEL AND FOR OTHER PURPOSES.

BE IT ORDAINED, by authority of the Municipal Board, of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of ₱382.80 or so much thereof is hereby reverted from out of salary savings in the Intermediate School Fund, 1964-1965 Ormoc City Budget, to be made available for appropriation to pay the balance of salary difference accruing to Mr. Asisclo S. Fiel, public school teacher, who is finishing his Master of Arts degree in Education course this summer.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
