RESOLUTION NO. 161

"The Board, on motion of Councilor Abas, seconded by Councilors Besabella and Du;

"RESOLVED, to adopt:

ORDINANCE NO. 56

AN ORDINANCE APPROPRIATING ₱9,000 FOR FREIGHT, INSURANCE, INSPECTION AND OTHER CHARGES AGAINST ORMOC CITY FOR FIVE JEEPS AND ONE FIRE TRUCK FROM REPARATIONS COMMISSION, JAPAN, AND FOR OTHER PURPOSES

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of ₱9,000.00 or so much thereof is hereby appropriated from funds in the city treasury not otherwise appropriated to be made available for freight, insurance, inspection and other charges for five jeeps and one fire truck allotted free from the Reparations Commission, Japan, through the National Civil Defense Administration, Manila, in the manner provided hereunder as follows:

a) Five (5) Reparation jeeps @ ₱1,000.00	₱ 5,000.00
b) One (1) Reparation fire truck	4,000.00
Total	₱ 9,000.00

SECTION 2. The City Treasurer is hereby authorized to make a corresponding supplemental budget to this effect and to issue a certification of availability of funds therefor with the concurrence of the City Auditor: PROVIDED, That the same will be converted into a check payable to the National Civil Defense Administration immediately upon notification by the latter that the five jeeps and one fire truck are already available for Ormoc City; pursuant to the instruction of Administrator Alfredo G. Eugenio, NCDA; Manila.

SECTION 3. This Ordinance shall take effect immediately upon its approval.

ENACTED, June 30, 1965.

"RESOLVED, FINALLY, to furnish a copy of this resolution each to Administrator Alfredo G. Eugenio, NCDA, Manila, the Chief of Police, the Chief of Fire, the City Treasurer and the City Auditor, all of Ormoc City;
