ORDINANCE NO. 6

AN ORDINANCE REVERTING THE SUM OF ONE HUNDRED FIFTY PEOS (\$\frac{1}{2}\$)
FROM OUT OF THE ITEM ON ILLUMINATION AND POWER SERVICE TO
SUPPLIES AND MATERIALS IN THE ORMOC CITY INTERMEDIATE
SCHOOL, DISTRICT II

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of OrmocCity, That:

SECTION 1. The sum of One Hundred Fifty Pesos (\$150) or so much thereof is hereby reverted from out of the provision for illumination and power service in the 1964-1965 Ormoc City for Ormoc District II, Ormoc City Intermediate School, to be made available for appropriation for supplies and materials under the same department.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
