"RESOLVED, to adopt:

ORDINANCE NO. 60

AN ORDINANCE OBLIGATING ₱2,000 UNDER CONTINGENT EXPENSES OF (C-5) FINANCE DEPARTMENT IN A SUPPLEMENTAL BUDGET FOR PUBLICATION OF REAL ESTATE TAX DELINQUENCIES FOR A MORE EFFECTIVE STRAIN AND LEVY, AND FOR OTHER PURPOSES.

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the Provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of ₱2,000 or so much thereof as may be necessary is hereby obligated under contingent expenses of (C-5) Finance Department, this City, in a supplemental budget for the publication of real estate tax delinquencies for a more effective strain and levy as provided for by law.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
