"RESOLVED, to adopt:

ORDINANCE NO. 61

AN ORDINANCE APPROPRIATING ₱396.94 OUT OF THE UNEXPENDED BALANCE FROM THE 1964-1965 ORMOC CITY BUDGET FOR OBLIGATION IN THE ENSUING 1965-1966 ORMOC CITY BUDGET AS PAYMENT FOR RENEWAL PREMIUM TO MASTER POLICY NO. PAA/LC-9028 OF ORMOC CITY BARRIO CAPTAINS WITH THE PHILIPPINE AMERICAN ASSURANCE COMPANY, INCORPORATED, FROM SEPTEMBER 30, 1965, TO SEPTEMBER 30, 1966.

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of ₱396.94 or so much thereof as may be necessary is hereby appropriated out of the unexpended balance from the 1964-1965 Ormoc City Budget for obligation in the ensuing 1965-1966 Ormoc City Budget to be made available for necessary expenses itemized as follows; for the period from September 30, 1965 to September 30, 1966:

- a) Renewal Premium on Master List BARRIO CAPTAINS
with the Philippine American Assurance Company,
Incorporated, per Master Policy No. PAA/LC-9028 .. ₱ 396.00
b) Documentary Stamps94
T O T A L ₱ 396.94

SECTION 2. This Ordinance shall take effect immediately upon its approval.
