ORDINANCE NO. 62

AN ORDINANCE APPROPRIATING ₱4,588.20 OUT OF THE UNEXPENDED BALANCE FROM THE 1964-1965 ORMOC CITY BUDGET FOR INCORPORATION IN THE ENSUING 1965-1966 ORMOC CITY BUDGET FOR CITY'S SHARE TO INSURANCE AND RETIREMENT GRATUITY PREMIUMS FOR OFFICIALS AND EMPLOYEES OF THE MUNICIPAL BOARD.

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of ~~three~~ ^{four} thousand five hundred eighty-eight pesos and twenty centavos (₱4,588.20), or so much thereof as may be necessary, is hereby appropriated out of the unexpended balance from the 1964-1965 Ormoc City Budget for incorporation in the ensuing 1965-1966 Ormoc City Budget to be made available for necessary insurance and retirement gratuity premiums for officials and employees of the Municipal Board with the Government Service Insurance System, Eastern Visayas Regional Office, Cebu City, itemized as follows:


SECTION 2. This Ordinance shall take effect immediately upon its approval.


