BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc 6ity, That:

SECTION 1. The sum of Two Hundred Forty Pesos (\$240), or so much thereof as may be necessary, is hereby appropriated but of the unexpended balance from the 1964-1965 Ormoc City Budget to be made available for payment of the uncollected salaries of Mrs. Filomena B. Montebon, City Court Stenographer, for the months of May and June, 1965, at the rate of ₱120 per month
