"RESOLVED, to adopt:

ORDINANCE NO. 65

AN ORDINANCE APPROPRIATING \$2,000 OUT OF THE UNEXPENDED BALANCE, 1964-1965 ORMOC CITY BUDGET, TO BE MADE AVAILABLE AS AID TO THE ORMOC PUERICULTURE CENTER AND MATERNITY HOUSE.

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of Two Thousand Pesos (P2,000), or so much thereof as may be necessary, is hereby appropriated out of the unexpended balance from the 1964-1965 Ormoc City Budget, said sum to be made available as aid to the Ormoc Puericulture Center and Maternity House for its operational expenses.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
