WHEREAS, to reciprocate the cooperation and job well done by the Bureau of Internal Revenue, particularly, the Inspection District No. 44, Ormoc City, thanks to the resourcefulness of its personnel headed by the energetic Chief Revenue Officer in the person of Atty. Fernando D. San Ramon, through whose efforts more income taxes have been channeled to this City, this august Body is more than willing to accede to his request;

ORDINANCE NO. 67

AN ORDINANCE APPROPRIATING THE SUM OF \$\frac{1}{2},\doc{0}{2}00.00 OUT OF THE JULY 1965 INCOME TAX SHARES ACCRUING TO OFF OFF OFF AS AID TO THE REVENUE INSPECTION DISTRICT NO. 44, BUREAU OF INTERNAL REVENUE, ORMOC CITY, PHILIPPINES, FOR THE CONSTRUCTION OF ITS OFFICE BUILDING KNOWN AS A TAXPAYERS! HALL OR BUREAU OF INTERNAL REVENUE BUILDING AT THE GOVERNMENT CENTER LOCATED AT COGON COMBADO, ORMOC CITY, AND CONDITIONALLY DONATING SAID BUILDING TOGETHER WITH THE LOT WHERE IT WILL BE ERECTED TO THE SAID REVENUE INSPECTION DISTRICT NO. 44, BUREAU OF INTERNAL REVENUE, ORMOC CITY, PHILIPPINES, AND FOR OTHER PURPOSES.

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of seventy-five thousand pesos (\$75,000.00), or so much thereof as may be necessary, is hereby appropriated out of the July 1965 Income Tax shares accruing to Ormoc City for the construction and drawing of a plan of an office building known as a "Taxpayers! Hall" or "Bureau of Internal Revenue Building" at the Government Center located at Cogon Combado, Ormoc City, Philippines, and donating said building together with the lot where it will be erected to the Revenue Inspection District No. 44, Bureau of Internal Revenue, Ormoc City, Philippines.

SECTION 2. The amount provided for in Section 1 hereof shall be made available to the Honorable City Mayor, the City Treasurer and the City Anditor of Ormoc who shall altogether compose the Committee on Awards to open, take charge and/or supervise a public bidding at Ormoc City among all interested private contractors and to hire the services of a private architect at a reasonable price to draw the plan and prepare the specifications of said building subject to the approval of the City Engineer of Ormoc who shall, likewise, supervise, check, inspect, determine and certify that said building is finished or completed with all the requirements, and specifications which are the conditions to the winner bidder-contractor are fully complied with before said committee acknowledges the receipt of the turning over of said building to said committee on awards.

SECTION 3. The Honorable City Mayor Esteban C. Conejos or his successor is hereby authorized to execute a deed of donation donating the said office building and the lot where it is erected to the Bureau of

Internal Revenue, Inspection District No. 44, Ormoc City, after the said office building had been duly certified by the City Engineer as finished in accordance with its specifications and accepted by said committee and said donation shall only become valid and executory upon its acceptance by the Chief Revenue Officer of the Revenue Inspection District No. 44, Ormoc City, and with the approval of the Honorable Commissioner of the Bureau of Internal Revenue and the Honorable Secretary of Finance, both of Manila, but the ownership of said building and lot shall be turned over to the City Government of Ormoc City, when same building and lot are no longer needed for the use of the Bureau of Internal Revenue.

SECTION 4. For the purpose of this Ordinance, the amount provided for in Section 1 hereof shall be made available only after the full amount of the shares accruing to Ormoc City up to July, 1965, shall have been realized and released by the Department of Finance or the Bureau of Internal Revenue, both of Manila.

SECTION 5. If any part or section of this ordinance shall be declared null and void, said part or section shall not invalidate the whole Ordinance.

SECTION 6. This Ordinance shall take effect immediately upon its approval.
