"RESOLVED, to adopt:

ORDINANCE NO. 68

AN ORDINANCE APPROPRIATING ₱492 FOR PAYMENT OF OUTSTANDING  
OBLIGATIONS OF SALARY DIFFERENCE TO MACRINO SAZO, JANI-  
TOR, CITY LIBRARY, AND ACCRUED VACATION AND SICK LEAVES  
TO THE LATE SUSANO SUSON, CAMPAIGN CLERK, FINANCE DEPART-  
MENT, AND FOR OTHER PURPOSES.

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City,  
Philippines, pursuant to the provisions of Republic Act 179, as amended  
by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of four hundred ninety-two pesos (₱492.00), or  
so much thereof as may be necessary, is hereby appropriated out of the  
unappropriated balance from the 1964-1965 Ormoc City Budget to be made  
available for payment of outstanding obligations as follows:

- a) To salary difference of Macrino Sazo, Janitor,  
City Library, from ₱4 a day to ₱120 a month  
from Nov. 5, 1964, to July 15, 1965, inclusive-₱332.00
- b) To claim of Candida Durano, spouse of the late  
Susano Suson, Campaign Clerk, Finance Depart-  
ment, for 2 months accrued vacation and sick  
leaves of the latter at ₱80 per month from Feb.  
9, to April 9, 1958, inclusive ..... - 160.00 ₱492.00

SECTION 2. This Ordinance shall take effect immediately upon its  
approval.
