"The Board, on motion of Councilor Abas, seconded by Councilor Du;

"RESOLVED, to adopt:

ORDINANCE NO. 69

AN ORDINANCE APPROPRIATING THE SUM OF ₱873.40 OUT OF UNAPPROPRIATED BALANCE, 1964-1965 ORMOC CITY BUDGET, TO BE MADE AVAILABLE FOR PAYMENT OF SALARY DIFFERENTIALS OF POLICE INSPECTOR FIRST CLASS ALFREDO D. SULLA AND PATROLMAN PONCIANO BACASON.

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of ₱873.40, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated balance, 1964-1965 Ormoc City Budget, to be made available for payment of salary differentials in the manner provided hereunder as follows:

- a) To Police Inspector Alfredo D. Sulla, from Sept. 27, 1964 at ₱2280 p.a. to Mar. 6, 1965, at ₱3120 p.a. and from Mar. 7, 1965, at ₱2400 p.a. to June 30, 1965, at ₱3120 p.a. ₱643.40
- b) To Patrolman Ponciano C. Bacason, from Oct. 16, 1964, at ₱1440 p.a. to April 15, 1965, at ₱1800 p.a. and from Apr. 16, 1965 at ₱1560 p.a. to June 30, 1965, at ₱1800 p.a. 230.00 ₱873.40

SECTION 2. This Ordinance shall take effect immediately upon its approval.
