ORDINANCE NO. 7

AN ORDINANCE REVERTING THE SUM OF ONE THOUSAND PESOS (\$1,000) FROM OUT OF ITEM NO. 38, C-15, PAGE 10, 1964-1965 ORMOC CITY BUDGET, TO PROVISIONS FOR SCHOOL AID TO LINAO

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of One Thousand Pesos (\$1,000) or so much thereof is hereby reverted from out of Item No. 38, C-15, Page 10, 1964-1965 Ormoc City Budget, otherwise known as item on one (1) police jeep to be made available for appropriation for the construction of one schoolroom as barrio and school aid to Linao, Ormoc City.

SECTION 2. This ordinance shall take effect immediately upon its approval.
