ORDINANCE NO. 70

AN ORDINANCE APPROPRIATING THE AMOUNT OF \$2.50 OUT OF UNAPPRO-PRIATED BALANCE, 1964-1965 ORMOC CITY BUDGET, TO BE MADE AVAILABLE FOR PAYMENT OF SALARY DIFFERENCE OF PATROLMAN FIRST CLASS JOSE VILLA.

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The amount of \$82.50, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated balance, 1964-1965 Ormoc City Budget, to be made available for the payment of salary difference of Patrolman First Class Jose Villa, OCPD, from \$1920 to \$1980 per annum for the period from July 1, 1964, to November 15, 1965, inclusive.
