"The Board, on motion of Floor Leader Tugonon, seconded by Councilor Alfaro;

"RESOLVED, to adopt:

ORDINANCE NO. 71

AN ORDINANCE APPROPRIATING THE SUM OF ₱228.00 OUT OF UNAPPROPRIATED BALANCE, 1964-1965 ORMOC CITY BUDGET, TO BE MADE AVAILABLE FOR PAYMENT OF SALARIES OF FIREMEN RUFINO CUESTA AND CONSTANCIO PIANO, OCFD.

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of ₱228.00, or so much thereof as may be necessary, is hereby appropriated out of unappropriated balance, 1964-1965 Ormoc City Budget, to be made available for the payment of salaries of two firemen at the rate of ₱1440 per annum each, viz:

- a) Fireman Rufino Cuesta, from September 16 to October 15, 1964, inclusive ₱120.00
- b) Fireman Constancio Piano, from October 5 to 31, 1964, inclusive 108.00 ₱228.00

SECTION 2. This Ordinance shall take effect immediately upon its approval.

ENACTED, November 17, 1965.

"RESOLVED, FINALLY, to furnish a copy of this resolution each to Firemen Rufino Cuesta and Constancio Piano, OCFD, the City Treasurer and the City Auditor, all of Ormoc City;
