"RESOLVED, to adopt:

ORDINANCE NO. 72

AN ORDINANCE APPROPRIATING ₱1,440 OUT OF COUNTERPART FUND FOR PACD PROJECTS, 1964-1965 ORMOC CITY BUDGET, TO BE MADE AVAILABLE FOR BACK AND CURRENT RENTALS OF THE BUILDING OWNED BY THE HEIRS OF THE LATE CATALINO MAGLASANG USED AS OFFICE AND WAREHOUSE OF THE PACD

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of ₱1,440.00, or so much thereof as may be necessary, is hereby appropriated out of Item 2, Counterpart Fund for PACD Projects, Capital Outlays, 1964-1965 Ormoc City Budget, page 14, said sum to be made available for rentals of the building owned by the Heirs of the Late Catalino Maglasang used as office and warehouse of the PACD, in the manner provided hereunder as follows:

- a) July 1 to Dec. 31, 1963, 6 mos. @ ₱60.00 ₱360.00
- b) July 1 to Dec. 31, 1964, 6 mos. @ ₱60.00 360.00
- c) Jan. 1 to Dec. 31, 1965, 6 mos. @ ₱60.00 720.00 ₱1,440.00

SECTION 2. This Ordinance shall take effect immediately upon its approval.

ENACTED, Dec. 1, 1965.
