ORDINANCE NO. 73

AN ORDINANCE REVERTING THE SUM OF ₱690 FROM SALARY SAVINGS
ACCRUING TO THE OFFICE OF THE CITY MAYOR TO BE MADE
AVAILABLE FOR APPROPRIATION FOR PAYMENT OF TERMINAL
LEAVE OF PATROLMAN VICTORIANO ZABATE, OCPD

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City,
Philippines, pursuant to the provisions of Republic Act 179, as amended,
otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of ₱690, or so much thereof as may be necessary,
is hereby ~~reverted~~ from salary savings accruing to the Office of the City
Mayor, particularly, Item No. 7, Agricultural Adviser and Fertilizer In-
Charge, said sum to be made available for appropriation to pay terminal
leave of Patrolman Victoriano Zabate of the Ormoc City Police Department.
