ORDINANCE NO. 8

AN ORDINANCE REVERTING THE SUM OF TWO THOUSAND SEVEN HUNDRED FORTY PESOS (\$2,740) FROM OUT OF ITEMS UNDER D-21, ORMOC CITY INTERMEDIATE SCHOOL FUND, PAGES 15 AND 16, 1964-1965 ORMOC CITY BUDGET, FOR SCHOOL GROUNDS AND CAFETERIA IM-PROVEMENTS, AND PAINTING OF FENCES, HOME ECONOMICS BUILD-ING, CITY GRANDSTAND FRONTAGE AND ATHLETIC ADMINISTRATION BUILDING OF THE ORMOC CITY CENTRAL SCHOOL

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of Two Thousand Seven Hundred Forty Pesos (\$2740) or so much thereof is hereby reverted from out of different items under (D-21) the Ormoc City Intermediate School Fund, pages 15 and 16, of the 1964-1965 Ormoc City Budget, to be made available for appropriation for school grounds and cafeteria improvements and the painting of fences, home aconomics building, city grandstand frontage and athletic administration building of the Ormoc City Central School, said reversion to be provided in the following manner hereunder stated:

Item 1, salary savings from City Principal position - ₱ 750.00 Item 16, salary savings from Clerk I 840.00 Item 31, District I, purchase of effice equipment Item 33, District I, playground apparatus 500.00 Total \$2740.00

SECTION 2. This Ordinance shall take effect immediately upon its approval.
