RESOLUTION NO. 15

"WHEREAS, Mr. Urbano Laurente, Barrio Captain of Cabulihan, this City, has made representations asking for ₱300 as required by the PACD as the barrio's counterpart for the waterworks project;

"NOW, THEREFORE, the Board, on motion of Councilor Alfaro, seconded by the Presiding Officer, the Floor Leader and all the Councilors present;

"RESOLVED, to adopt:

ORDINANCE NO. 9

AN ORDINANCE REVERTING THE SUM OF THREE HUNDRED PESOS (₱300) FROM OUT OF ITEM NO. 14, C-16, PAGE 11, ORMOC CITY BUDGET, FOR BARRIO AID TO CABULIHAN TO BE MADE AVAILABLE AS ITS COUNTERPART FOR THE PACD WATERWORKS PROJECT

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, pursuant to the provisions of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, That:

SECTION 1. The sum of Three Hundred Pesos (₱300) or so much thereof is hereby reverted from out of Item 14, C-16, page 11, 1964-1965 Ormoc City Budget, otherwise known as provision for one fire truck, locally mounted, to be made available for appropriation for barrie aid to Cabulihan as the barrio's counterpart for the PACD waterworks project in the said community;

SECTION 2. This Ordinance shall take effect immediately upon its approval.
