"Resolved, to adopt:

ORDINANCE NO. 1

AN ORDINANCE APPROPRIATING THE SUM OF ₱140 OUT OF THE DISCRETIONARY FUND OF THE CITY MAYOR TO BE MADE AVAILABLE FOR PAYMENT OF ONE WHOLE PAGE ADVERTISEMENT OF ORMOC CITY OFFICIALS IN THE CHRISTMAS ISSUE OF "THE CEBU REVIEW"

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, that:

SECTION 1. The sum of One Hundred Forty Pesos (₱140.00), or so much thereof as may be necessary, is hereby appropriated out of the discretionary fund of the City Mayor to be made available for payment of one whole page advertisement of Ormoc City Officials in the Christmas issue of "The Cebu Review" in accordance with the advertisement agreement dated December 29, 1965, entered into by and between the Ormoc City Government represented by His Honor, the City Mayor, and the editor of the said paper;

SECTION 2. This Ordinance shall take effect immediately upon its approval.
