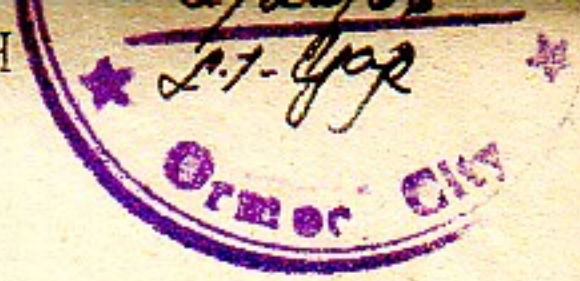


EXCERPT FROM THE MINUTES OF THE REGULAR SESSION OF THE FIFTH
MUNICIPAL BOARD OF ORMOC CITY, PHILIPPINES, HELD AT ITS
SESSION HALL ON FEBRUARY 16, 1966

RESOLUTION NO. 32

"WHEREAS, the Chief of Police in his communication dated January 4, 1966, had requested that with the creation of new positions of four patrolmen under the Uniform Division of the Ormoc City Police Department it has become necessary to increase by one the number of police corporals in order that in charge of the warrant section who has long been in the service but always on the rear rank could be promoted to police corporal considering that he is now a civil service eligible;

"WHEREAS, in another communication dated January 19, 1966, the Chief of Police had, likewise, made representations for amendments to Items No. 19 and No. 20 under the Secret Service Division of (C-15) Police Department, more particularly page 11 of the 1965-1966 Ormoc City Budget, so that one Patrolman First Class from Item No. 20 will be elevated to the rank of Detective Corporal to Item No. 19 and so that Item No. 19 will have now five (5) Detective Corporals @ P2,400 per annum effective October 1, 1965, while Item No. 20 will have only four (4) Patrolmen First Class @ P2,280.00 per annum effective October 1, 1965;

"WHEREAS, acting on a communication dated February 16, 1966, the Honorable Committee on Police and Fire of this August Body has recommended, with the general acquiescence of the Board, the transfer of one patrolman of the Uniform Division to the Secret Service Division of the Ormoc City Police Department without necessarily increasing his salary from his present compensation rate;

"WHEREAS, with respect to the promotion of the in charge of the warrant section in the Uniform Division of the Ormoc City Police Department, it has been agreed that said promotion from patrolman to corporal does not carry with it a corresponding salary promotion as in the case of the transfer of one patrolman from the Uniform Division to the Secret Service Division;

"NOW, THEREFORE, the Board, on motion of Councilor Abas, seconded by Councilors Besabella and Du;

"RESOLVED, to adopt:

ORDINANCE NO. 10

AN ORDINANCE AMENDING CERTAIN ITEMS UNDER (C-15) POLICE DEPARTMENT OF THE 1965-1966 ORMOC CITY BUDGET AND FOR OTHER PURPOSES.

BE IT ORDAINED by authority of the Municipal Board of Ormoc City, Philippines, That:

SECTION 1. The positions of two (2) Patrolmen with compensation each at the rate of P2,160.00 per annum effective October 1, 1965, (from P1,800.00) are hereby withdrawn from Item No. 12 under (C-15) Police Department, page 11, 1965-1966 Ormoc City, Budget, so that

a) One (1) Patrolman will be promoted to Corporal (in charge of warrant section); ~~without~~ salary promotion; and

b) One (1) Patrolman will be transferred to the Secret Service Division without salary promotion.

SECTION 2. Consequent to the promotion and transfer, respectively, provided for in Section 1 hereof, Item No. 12 under (C-15) Police Department, page 11, 1965-1966 Ormoc City Budget, is hereby amended to read as follows:

"12 : 12 Twenty-Five (25) Patrolmen @ ₱2,160.00
effective October 1, 1965 (from ₱1,800.00)... ₱51,750.00"

SECTION 3. (C-15) Police Department, page 11, 1965-1966 Ormoc City Budget, is hereby amended by inserting an item between Item No. 11 and Item No. 12, to be known as Item No. 11-A, which shall hereinafter read as follows:

"11-A : 12 One (1) Police Corporal at ₱2,160.00 effective October 1, 1965 (from ~~Patrolman~~ at ₱1,800.00) ₱ 2,070.00

SECTION 4. Items No. 19 and No. 20 under (C-15) Police Department, Secret Service Division, page 11, 1965-1966 Ormoc City Budget, are hereby amended to read as follows:

"19 : 18 Five (5) Detective Corporals @ ₱2,400.00 effective October 1, 1965 (from four Police Corporals and one Patrolman First Class @ ₱1,980.00) ₱11,475.00

"20 : 19 Four (4) Patrolmen First Class @ ₱2,280.00 effective October 1, 1965 (from ₱1,920.00) ₱ 8,760.00"

SECTION 5. (C-15) Police Department, page 11, 1965-1966 Ormoc City Budget, is hereby amended, further, by inserting an item between Item No. 20 and Item No. 21 (from Item No. 12), to be known as Item No. 20-A, which shall hereinafter read as follows:

"20-A : 12 One (1) Patrolman First Class at ₱2,160.00 effective October 1, 1965 (from Patrolman at ₱1,800.00) ₱ 2,070.00"

SECTION 6. This Ordinance shall take effect immediately upon its approval.

ENACTED, February 16, 1966.

"RESOLVED, FINALLY, to furnish a copy of this resolution-ordinance each to the Chief of Police for his information and guidance for reorganization, the City Treasurer and the City Auditor, all of Ormoc City;
"CARRIED UNANIMOUSLY."
