AN ORDINANCE REVERTING \$\frac{1}{2}800.00 FROM OUT OF SALARY SAVINGS ACCRUING TO ANY AND ALL DEPARTMENTS OR OFFICES OF THE CITY GOVERNMENT TO BE MADE AVAILABLE FOR TRAVELING EXPENSES OF FOUR POLICE ESCORTS TO CONDUCT EIGHT INSULAR PRISONERS TO THE NATIONAL PENITENTIARY.

BECTTOORDAINED, by authority of the Municipal Board of Ormoc City, Philippines, That:

SECTION 1. The sum of Eight Hundred Pesos (\$\mathbb{P}800.00), or so much thereof as may be necessary, is hereby reverted from out of salary savings accruing to any and all departments or offices of the City Government to be made available for appropriation for actual and necessary traveling expenses of four (4) police escorts to conduct eight (8) insular prisoners to the National Penitentiary, Muntinlupa, Rizal.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
