"The Board, on motion of Councilor Abas, seconded by Councilors Alfaro and Besabella;

"RESOLVED, to adopt:

**ORDINANCE NO. 12**

AN ORDINANCE REVERTING THE SUM OF P234.90 FROM SALARY SAVINGS ACCRUING TO ANY AND ALL DEPARTMENTS OR OFFICES OF THE CITY GOVERNMENT TO BE MADE AVAILABLE FOR SUPPLEMENTAL APPROPRIATION FOR TRAVELING EXPENSES OF THE POLICE DEPARTMENT.

BE IT ORDAINED, by authority of the Municipal Board of Ormoc City, That:

SECTION 1. The sum of Two Hundred Thirty-Four Pesos and Ninety Centavos (P234.90), or so much thereof as may be necessary, is hereby reverted from salary savings accruing to any and all departments or offices of the City Government to be made available for supplemental appropriation for traveling expenses of the Police Department in the manner provided hereunder as follows:

- 1) For the Chief of Police to attend a conference  
in Cebu City on March 25, 1966 ..... P100.00
- 2) For Det. Demetrio Tan, to reimbursement of actual and necessary travel and transportation while escorting insular prisoners to the Bureau of Prisons, Muntinlupa, Rizal ..... 134.90 P 234.90

SECTION 2. This Ordinance shall take effect immediately upon its approval.




