RESOLUTION NO. 70

"WHEREAS, this august Body will remember having passed Resolution No. 67 on March 30, 1966, actually implementing Republic Act 4477 standardizing the salaries of the City Mayor, Vice-Mayor, City Councilors, Department Heads, Assistant Department Heads and the Secretaries to the Mayor and Municipal Board, effective as of July 1, 1965, in line with the category of the Ormoc City as a Third Class Chartered City, having in mind the provision, among other things, of said Republic Act 4477 'that the Secretary of Finance is authorized to reduce the classification of city to a lower class for its failure to implement said Act';

"WHEREAS, with the passage of our Resolution No. 67, current series, the Office of the City Treasurer had submitted a list of city officials affected by salary adjustments in accordance with Republic Act 4477 whose salary differentials would aggregate a sum of ₱48,380. more or less;

"WHEREAS, taking into account that our unappropriated balance in the General Fund is so little that it cannot afford to cover the salary adjustments so much so that this Board is constrained to revert sufficient sum from different items such as salary savings, unexpended contingent expenses, aids and transfer of funds and capital outlays in order to meet the required or necessary amount to effect said salary adjustments starting from July 1, 1965;

"NOW, THEREFORE, the Board, on motion of Councilor Abas, seconded by Councilor Du;

"RESOLVED, to adopt:

ORDINANCE NO. 15

AN ORDINANCE REVERTING THE SUM OF FORTY EIGHT THOUSAND THREE HUNDRED EIGHTY PESOS (₱48,380.00) FROM OUT OF THE SALARY SAVINGS, CONTINGENT EXPENSES, AIDS AND TRANSFER OF FUNDS AND CAPITAL OUTLAYS IN THE 1965-1966 ORMOC CITY BUDGET TO BE MADE AVAILABLE FOR SUPPLEMENTAL APPROPRIATION FOR THE SALARY ADJUSTMENTS OF CITY OFFICIALS EFFECTIVE AS OF JULY 1, 1965, IN CONSONANCE WITH REPUBLIC ACT 4477 AND IN LINE WITH THE CATEGORY OF ORMOC CITY AS A THIRD CLASS CHARTERED CITY

BE IT ORDAINED by the Municipal Board of Ormoc City, Philippines,
That:

SECTION 1. That the sum of Forty Eight Thousand Three Hundred Eighty Pesos (₱48,380.00) or so much thereof as may be necessary, is hereby reverted from out of salary savings, contingents expenses, aids and transfer of funds, and capital outlays not otherwise expended in the 1965-1966 Ormoc City Budget said sum to be made available for supplemental appropriations to cover the salary adjustments of the City



Mayor, Vice-Mayor, City Councilors, Department Heads, Assistant Department Heads, and the Secretaries to the Mayor and the Municipal Board, in consonance with Republic Act 4477 and in line with the category of Ormoc City as a Third Class Chartered City, said reversion to be made available in the manner hereinunder provider:


SECTION 2. This Ordinance shall take effect immediately upon its approval.
