ORDINANCE NO. 16-A

AN ORDINANCE AMENDING FURTHER ORDINANCE NO. 74, SERIES OF 1965, BY TRANSFERRING ONE NEW POSITION OF PATROLMAN FROM THE POLICE DEPARTMENT TO FIREMAN OF THE FIRE DEPARTMENT CARRYING WITH IT THE SAME RATE OF COMPENSATION EFFECTIVE AS OF JANUARY 1, 1966.

BE IT ORDAINED by the Municipal Board of Ormoc City, Philippines, That:

SECTION 1. The position of one (1) new Patrolman from out of Item No. 14 under C-15, Police Department, is hereby transferred to Fireman to be known as Item No. 11-A under C-16, Fire Department, so that these items provided for in Ordinance No. 74, series of 1965, are hereby amended to read:

(C-15) Police Department

Item No. 14 : New : Three (3) Patrolmen @ ₱1,800.00 effective
January 1, 1966 ₱2,700.00

(C-16) Fire Department

Item No. 11-A : New : One (1) Fireman at ₱1,800.00 effective
January 1, 1966 900.00

SECTION 2. This Ordinance shall take effect immediately upon its approval.
