"RESOLVED, to adopt:

ORDINANCE NO. 18

AN ORDINANCE SUSPENDING THE EFFECTIVITY OF ORDINANCE NO. 58, SERIES OF 1965, ENTITLED "AN ORDINANCE ALLOWING FIESTA CELEBRATIONS IN DISTRICTS, BARRIOS AND SITIOS OF ORMOC CITY ONLY ONCE EVERY CALENDAR YEAR AND FOR OTHER PURPOSES."

BE IT ORDAINED by the Municipal Board of Ormoc City, That:

SECTION 1. The effectivity of Ordinance No. 58, series of 1965, entitled "AN ORDINANCE ALLOWING FIESTA CELEBRATIONS IN DISTRICTS, BARRIOS AND SITIOS OF ORMOC CITY ONLY ONCE EVERY CALENDAR YEAR AND FOR OTHER PURPOSES," is hereby suspended up to June 30, 1967, and that the same shall take effect immediately on July 1, 1967.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
