"RESOLVED, to adopt:

ORDINANCE NO. 20

AN ORDINANCE REVERTING THE SUM OF ₱2,117.00 FROM ITEM NO. 7, CAPITAL OUTLAYS, PAGE 17, 1965-1966 ORMOC CITY BUDGET, TO BE MADE AVAILABLE FOR THE BALANCE OF PAYMENT TO HERMOGENES SANCHEZ FOR THE USE AND OCCUPANCY OF 1170 SQUARE METERS OF HIS LOT NO. 1387 IN CONNECTION WITH THE EXTENSION OF SAN JORGE AND BONIFACIO STREETS AND AUTHORIZING THE CITY TREASURER TO SET OFF THE AMOUNT OF ₱866.63, MORE OR LESS, CORRESPONDING TO ARREARS IN TAXES CHARGED AGAINST HIM.

BE IT ORDAINED by the Municipal Board of Ormoc City, Philippines, That:

SECTION 1. The sum of ₱2,117.00, or so much thereof as may be necessary, is hereby reverted from out of Item No. 7, Capital Outlays, page 17, 1965-1966 Ormoc City Budget, to be made available for the balance of payment to Hermogenes Sanchez for the use and occupancy of 1,170 square meters of his Lot No. 1387 in connection with the extension of San Jorge and Bonifacio Streets: PROVIDED, HOWEVER, That the City Treasurer shall be authorized to set off the amount of ₱866.63, more or less, corresponding to arrears in taxes due the City Government charged against the said Hermogenes Sanchez.

SECTION 2. This Ordinance shall take effect immediately upon its approval.

"RESOLVED, FINALLY, to furnish a copy of this resolution each to the City Treasurer, the City Auditor, and Mr. Hermogenes Sanchez, all of Ormoc City;
