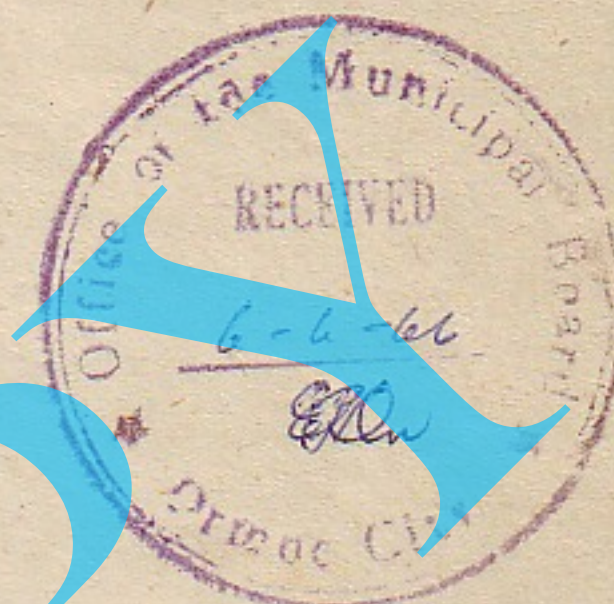
EXCERPT FROM THE MINUTES OF THE REGULAR SESSION OF THE FIFTH

RESOLUTION NO. 108

"The Board, on motion of Councilor Abas, seconded by Councilor Besa-
bella;

"RESOLVED, to adopt:

ORDINANCE NO. 21

AN ORDINANCE AMENDING FURTHER ORDINANCE NO. 3, AS AMENDED BY
ORDINANCE NO. 26, BOTH SERIES OF 1965, ENTITLED "AN ORDI-
NANCE REGULATING THE OPERATION AND MAINTENANCE OF A THREE-
WHEELED MOTOR VEHICLE AS A PUBLIC CONVEYANCE IN THE CITY
OF ORMOC, AND FOR OTHER PURPOSES."

BE IT ORDAINED by the Municipal Board of Ormoc City, Philippines,
That:

SECTION 1. Ordinance No. 3, as amended by Ordinance No. 26, both
series of 1965, entitled "An Ordinance Regulating the Operation and
Maintenance of a Three-Wheeled Motor Vehicle as a Public Conveyance in
the City of Ormoc, and for other purposes," is hereby amended, further,
by inserting certain provisions between Section 1 and Section 2 thereof
to be known as Section 1-A and Section 1-B which shall read as follows:

"SECTION 1-A. The operation or area limit for three-
wheeled motor vehicles to carry or transport passengers
shall be:

- 1) to the Northwest, up to Barrio ^{Linao} ~~Punta~~ only; *J*
- 2) along the national highway going to Tacloban,
up to Barrio Simangan only;
- 3) along the national highway going to Merida,
up to San Isidro (formerly Barrio Owak)
only; and
- 4) along the national highway going to Albuera,
up to Barrio Ipil only;

"SECTION 1-B. All three-wheeled motor vehicles shall be sub-
mitted annually for measurement at the Office of the Motor Vehicle
Registrar, Land Transportation Commission, Ormoc City, to determine
the passenger capacity and shall be granted permit only after a
certification shall have been issued by the Motor Vehicle Registrar."

SECTION 2. This Ordinance shall take effect immediately upon its
approval.


ENACTED, May 25, 1966.
